DAC wins the IIJ Partner of the Year 2022 Business Innovation Award

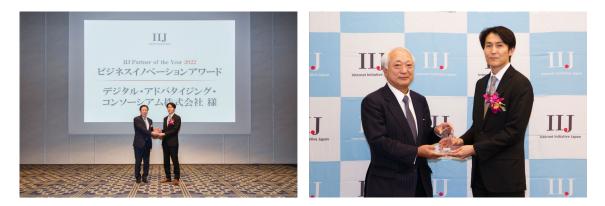
